In addition to the annual budget process, Glenn was instrumental in securing the lien on the fire-starting slip to address the losses to our members, while we start reconstruction this spring. Though it has been frustrating in permitting and process, his goal it to ensure that the membership is made whole during this process, we zero cost back to the membership.

With his leadership, we currently have a Reserve Fund Assessment Committee that is discussing the options to increase our reserves in an equitable manner for the entire membership for the many challenges that will befall us in the future. In his next term he will continue the zero-budget balancing process to ensure our dues are fiscally managed to the law as well as for the membership.
